- Demonstrated academic achievement
- Demonstrated financial need

- Participation in community involvement

## **Student Application Requirements\*:**

- 1. Official Transcript
- 2. Copy of an acceptance letter from a two or four year college/university or professional school
- 3. Expected Family Contribution (EFC) amount from the Federal Student Aid (FAFSA)
- 4. Completed financial summary
- 5. Completed scholarship application

  - Academic Achievement 30%
  - Extra-curricular 10%
  - Community Involvement 10%
  - Interview 10%
- Decisions of the selection committee are final
